Is there anything I need to know about this course?

There is government funding available for this course as part of the Free Courses for Jobs scheme. Eligibility criteria applies, to be eligible, you must:

- aged 19 or above on 31 August within funding year 2026 to 2027, enrol on the FCFJ qualifications approved for funding and meet the eligibility of being below the earnings threshold or unemployed
- or aged 19 to 23 on 31 August within funding year 2026 to 2027, enrol on the FCFJ qualification approved for funding, have not achieved a full level 3 and earn above the earnings threshold criteria.
